Monument to U.S. Merchant Marine Unveiled at Utah Beach

On June 5, the American Merchant Marine Veterans unveiled a monument to the U.S. Merchant Marine on Utah Beach. The new monument, near the Lone Sailor Monument and the Higgins Boat Monument, honors the valor and sacrifice of U.S. merchant mariners, whose actions supported military operations on D-Day that took place 80 years ago on June 6, 1944. American Maritime Officers and other U.S. maritime unions contributed financially to the creation of the new monument.

On D-Day, the Allies' armada and invasion forces landing in Normandy created the largest amphibious assault operation in the history of the world.

The Allies' D-Day armada numbered about 7,000 ships, including 200 U.S.

On May 8, 1945, the Supreme Commander of Allied Forces in the European Theater, General Eisenhower, said:

"Every man in this Allied command is quick to express his admiration for the loyalty, courage, and fortitude of the officers and men of the merchant marine. We count upon their efficiency and their utter devotion to duty as we do our own; they have never failed us yet and in all the struggles yet to come we know that they will never be deterred by any danger, hardship, or privation. When final victory is ours there is no organization that will share its credit more deservedly than the merchant marine."

Participants at the unveiling ceremony included U.S. Merchant Marine World War II Veteran Dave Yoho; Mayor Charles de Vallavieille of Sainte-Marie-du-Mont, Normandy, France; President of American Merchant Marine Veterans Capt. Dru DiMattia; and Rita Cosby, award-winning journalist, news anchor, and author. The small town of Sainte-Marie-du-Mont and the French people in Normandy extended wonderful hospitality for the event.

"It was something I never ever expected to get in on, but I'm so thankful I was here. It is the highlight in my life and it's something I can't explain to anyone," said World War II U.S. Merchant Marine Veteran Reynolds Tomter, age 107.

"It's important because we were almost forgotten about, and now we're remembered," said World War II U.S. Merchant Marine Veteran Joachim Kallist.

Delivery of Humanitarian Assistance to Gaza Continues as Floating Pier Is Toggled to Account for High Seas

On June 19, U.S. Central Command personnel supporting the mission to deliver much-needed humanitarian aid to Palestinian civilians, re-anchored the temporary pier to the beach in Gaza.

U.S. Central Command (U.S. CENT-COM) had announced June 14 the Joint Logistics Over the Shore (JLOTS) pier was being disconnected and towed to the Port of Ashod, Israel. The temporary pier was relocated to avoid expected high seas and to ensure the structural integrity of the pier and safety of U.S. service members. At no time did U.S. troops enter Gaza.

Trucks carrying humanitarian assistance across the temporary pier resumed delivery again on June 20, and approximately 656 metric tons (1.4 million pounds) of aid were delivered to the beach in Gaza. This was so far the largest single-day delivery of aid to date.

As of June 20, more than 4,160 metric tons (9.1 million pounds) of humanitarian aid in total had been delivered from the pier to the marshaling area, where the cargo can be collected by humanitarian organizations for onward delivery into Gaza.

As noted, due to expected high seas, U.S. CENTCOM reported June 14 the

temporary pier was to be removed from its anchored position in Gaza and towed back to Ashod. The safety of U.S. service members is a top priority and relocating the pier prevented structural damage that could have been caused by the heightened sea state.

The decision to temporarily relocate the pier is not made lightly but is necessary to ensure the temporary pier can continue to deliver aid in the future.

After the period of expected high seas, the pier was rapidly re-anchored to the coast of Gaza.

The capability of disconnecting and temporarily relocating the JLOTS pier was exercised in the wake of events in late May, in which heavy sea states damaged the pier, and prior also impacted four U.S. Army vessels supporting the maritime humanitarian aid mission in Gaza.

The vessels broke free from their moorings and two were beached on the coast of Israel near Ashkelon. They were recovered with assistance from the Israeli Navy and without U.S. personnel entering Gaza. The pier was moved to Ashod and re-

ARC Adds Starlink Satellite Internet for Entire U.S.-Flag Fleet

The following is excerpted from an article released June 11 by American Roll-On Roll-Off Carrier Group. American Maritime Officers represents all licensed officers onboard nine of the company's vessels.

PONTE VEDRA BEACH, FL — American Roll-On Roll-Off Carrier Group Inc. (ARC), the leading provider of U.S.-flag roll-on rolloff shipping, has added Starlink satellite Internet technology to its entire American-flagged fleet to help mariners stay connected with loved ones while at sea.

"Our mariners are the most important asset we have," said Eric Ebeling, ARC President and CEO. "They put in long weeks at sea and make tremendous personal sacrifices in order to help our military partners move critical vehicles and materials to strategically important regions of the world. This new technology allows ARC's crews to maintain contact with family and friends ashore while delivering for the American government."

The welcome news comes at a time when reliable connectivity is at the forefront of the minds of potential mariners thinking about a life at sea, said American Maritime Officers National Vice President, Deep Sea, Jeff Richards.

"I talk to a lot of junior members who do most if not all of their banking online. This connectivity allows our mariners the opportunity to stay current with financial matters while at sea," he said. "Equally, or some would say more importantly, mariners are able to stay in touch with family and friends from anywhere around the globe."

"Wi-Fi has become a necessity for many mariners, rather than a luxury," said Seafarers International Union (SIU) Communications Director Jordan Biscardo. "Improving seafarer quality of life is a priority and we are glad to see that ARC is making improvements like adding Starlink to the ships they are working on."

Starlink, operated by SpaceX, leverages low-Earth orbit satellites to enable access to high-speed Internet connections in remote areas, including for mariners at sea. Adding this new ability removes one of the main barriers to life at sea. It improves the quality of life for ARC's mariners by enabling communication with loved ones, access to streamed movies, shows, and music, or downloadable e-books.

Starting in early 2023, ARC has been adding Starlink to its vessels one by one, finishing installation on its newest vessel, *M/V ARC Honor*, in February of this year. In addition to supporting the wellness of seafarers, the move to add Starlink across the entire ARC fleet will also improve security and communications onboard the vessels.

ARC provides government services including global logistics and shipping services. ARC and its U.S. affiliates own and manage the largest U.S.-flag RO/RO fleet. This includes providing American-owned, managed, and crewed RO/RO shipping and intermodal services.



U.S. Coast Guard: Extension of Grace Period for Renewal of Expired Merchant Mariner Credentials Without Complete Original Exam

The following bulletin dated April 26 was released by the U.S. Coast Guard.

The Office of Merchant Mariner Credentialing (CG-MMC) Assistant Commandant for Prevention Policy (CG-5P) has published CG-MMC Policy Letter 01-24, Temporary Extension of Administrative Grace Period for Credentialing Transactions.

This policy letter will allow mariners to renew a merchant mariner credential (MMC) up to six years after its expiration without taking the complete original examination. All other credentialing requirements for renewal after expiration remain unchanged, and so in some circumstances an open book examination may be required in accordance with 46 CFR 10.227(e)(1).

Mariners who previously applied for renewal of their MMC after the one-year grace period had expired may re-apply for renewal if they are within the new, extended grace period.

A new application will be necessary, including payment of required fees, per 46 CFR 10.219. If you have a current approval to test letter issued by the National Maritime Center (NMC) to re-instate an MMC expired beyond the one-year administrative grace period but within six years, please contact the NMC at IASKNMC@uscg.mil or (888) 427-5662.

This policy letter is effective immediately and will remain in effect indefinitely. The Coast Guard will provide additional guidance concerning expiration of this policy as necessary. AMO Joins Seagoing Labor Community in Mourning the Loss of Nicholas Celona

Seafarers International Union Vice President of Government Services Nicholas Celona died at his home in New Orleans, La. on June 8, apparently from natural causes. He was 65.

"Back in the early 1980s, Nick and I had the privilege of working together in the port of New Orleans, a time during which we forged a lifelong friendship," said SIU President David Heindel. "Nick was a rare individual, brimming with a huge heart and an unwavering love for life. His infectious enthusiasm and unadulterated bravado left an indelible mark on everyone he met. As we remember Nick, we celebrate not only a dedicated seafarer but also a beloved father and friend who enriched our lives in countless ways. My deepest sympathies to his wife, Denise, and daughters Jennifer and Danielle."

"Many AMO hawsepipers got to

know Nick during their years sailing with the SIU, some from the very beginning of their careers. For all of us who have worked shoreside, Nick was a driving force and steadfast presence at many of the events and meetings that brought the U.S. seagoing labor community together to advance the cause of American mariners professionally and politically," said American Maritime Officers National President Willie Barrere. "He was a leader we had the pleasure of knowing and a man we mourn in his passing."

Celona had served as a vice president with the SIU since 2021. He worked as a patrolman in New Orleans from 1983 to 1988. He spent 1989 serving as the port agent in Piney Point before what turned out to be a long-term move to the West Coast. Celona was the union's San Francisco port agent from 1990 to 1994, the year he became an SIU assistant vice president.

Among other activities, he served as a delegate on the San Francisco-Alameda Labor Council, secretary-treasurer of the local port council, and a governor-appointed member of the board of directors of the Cow Palace (a popular arena in Daly City, California).

Always politically active, Celona organized the union's annual Thanksgiving gatherings in San Francisco and Oakland. Those feasts evolved into a Who's Who of politics, with regular appearances from Kamala Harris, Nancy Pelosi, John Garamendi, Eric Swalwell, Jackie Spier and many others. Based on his extensive work with the military, Celona in 2002 was sworn in as an honorary U.S. Marine, a rarity.

A 1977 graduate of Paul Hall Center Trainee Class 229, Celona was born and raised in Brooklyn, New York. He gradu-



ated from Lafayette High School in 1976 and soon thereafter found a home with the SIU. After completing the trainee program, he sailed in the engine department until 1982, upgrading several times along the way (most recently to chief electrician). He sailed on vessels operated by Sea-Land, Maritime Overseas, Delta Line, American Hawaii Cruises, Bay Tankers and others.

Captain Patrick J. Nelson: 1952-2024

Patrick James Nelson, known affectionately to friends and family as Captain Pat, embarked on his final voyage on May 29, 2024, at Henry Ford Hospital in Detroit. Born on October 10, 1952, in Port Huron, Michigan, he was the cherished son of the late Gordon and Elizabeth Ann (Cantrell) Nelson. Captain Pat's life was a testament to his loving, creative, and courageous spirit, and his legacy will be felt across the waves of the Great Lakes and in the hearts of those he touched.


Captain Pat's journey began as a deckhand at the age of 18, and his passion for the maritime life led him to a distinguished career as a captain of freighters on the Great Lakes. He retired in 2018 after nearly 50 years of service, with his final years spent with the American Steamship Company. He was preceded in death by his father, Gordon Nelson; his mother, Elizabeth "Betty" Nelson; his brother David Nelson, and his sister Mary Green.

When he wasn't at the helm or charting courses, Captain Pat could be found using his drone to film the freighters on the Great Lakes, a hobby that combined his love for technology and his lifelong maritime passion. He was also a dedicated supporter of his grandchildren's sporting events, always present in the stands, cheering them on with pride and enthusiasm. His time at the pool house was cherished by family and friends, where many unforgettable memories were made. His love of gathering with others combined with his great generosity made his hospitality legendary.

Captain Pat's life was a voyage of love, creativity, and courage. He navigated the waters of life with the same skill and dedication that he brought to his career on the Great Lakes. He prioritized relationships, valuing time with friends and family, loving to joke and laugh together.



His presence was a beacon of strength and warmth, guiding those around him through calm and stormy seas alike.

As we bid farewell to Captain Pat, we reflect on a life well-lived and a journey well traveled. Sailing members, officials and representatives of American Maritime Officers participated in observances of National Maritime Day across the nation on May 22, including ceremonies in Washington, D.C.; Norfolk, Va.; Galveston, Texas; San Pedro, Calif.; and Dania Beach, Fla.

Speakers at the National Maritime Day ceremony hosted by the Department of Transportation in Washington, D.C. included U.S. Secretary of Transportation Pete Buttigieg, who made a presentation by video, Maritime Administrator Ann Phillips, Commander of U.S. Transportation Command Gen. Jacqueline Van Ovost, Seafarers International Union President David Heindel, Senator Mark Kelly (D-AZ), and Secretary of the Navy Carlos Del Toro.

"Over the years, I've met a lot of World War II veteran mariners and truly they are the greatest generation. I've sat with the men themselves and they kept going back to sea because they loved their country and they wanted to contribute to victory. In many cases, they ended up in the merchant marine because they had health issues that may have precluded them from joining military service," SIU President Heindel said.

"The U.S. Merchant Marine has been a key part of this nation since America's

earliest days. And in all the years since then, one thing hasn't changed and never will: Give us the ships, give us the cargo, and we'll deliver," he said.

"The success of our military is dependent on these future credentialed mariners ... It is the dedication and expertise of our merchant mariners that create the backbone of our marine transportation system," Gen. Van Ovost said.

"We are a maritime nation and a

global sea power, not only because of the waters America has been blessed with and not only because of the technological prowess of our seafaring vessels in a tradition that goes back to the *S/S Savannah*. But above all, because of the people who have shaped the maritime sector, the people who sail those waters and crew and guide those vessels," Secretary of Transportation Buttigieg said.

"Maritime Day is our annual oppor-

"Securing America's maritime prosperity and the mariners who make it possible is not a new mission — it is our founding mission. History reveals that no nation has endured as a great naval power without also being a commercial maritime power, both in shipbuilding and shipping," Secretary of the Navy Del Toro said. "And for the first time in 125 years, we have a full-spectrum, global maritime competitor."

"This National Maritime Day, we remember that America has always been a seafaring nation, a fact that has underpinned our economic prosperity and national security for centuries," Senator Kelly said. "I'm committed to revitalizing our shipbuilding industry and reclaiming our maritime leadership."

A Proclamation on National Maritime Day, 2024

Our Nation's merchant mariners embody the highest aspirations of our democracy, always answering our country's call with commitment and courage. Today, we honor their service and sacrifice. Together, we recommit to meeting our sacred obligation to care for them and their families.

Unbreaking and unbending in their devotion to duty, our merchant mariners have stood for our Nation's freedom and liberty throughout history – from delivering critical goods and troops to the battlefields of World War II to responding to devastating natural disasters around the world and shipping the goods and military cargo that keep our Nation safe and prosperous. Today, our merchant mariners are continuing this legacy of service, delivering humanitarian aid to people in need and transporting military equipment around the world. At the same time, merchant mariners are engines of our economy. They facilitate international trade and strengthen our supply chains by transporting billions of dollars of goods across oceans, seas, and waterways to the hands of American businesses and consumers.

Our merchant mariners have always met the moment – and my Administration will always have their backs. That is why we are ensuring that ships traveling between United States ports are American-built, American-owned, and American-crewed by enforcing the Jones Act. This will not only support American shipbuilding but will also support good union jobs. Meanwhile, we have made historic investments in our Nation's infrastructure, including rebuilding our ports so that they are safer, cleaner, and easier and more affordable to move through.

We also recognize that our merchant mariners are strongest when they reflect the full diversity of our Nation. My Budget proposes \$191 million for the United States

Merchant Marine Academy to educate and train the next generation of seagoing officers and maritime leaders. Additionally, my Administration established Every Mariner Builds A Respectful Culture Standards to prevent sexual assault and harassment and to support survivors.

Today, as we honor all that merchant mariners have done for our Nation, we also recognize the mariners who have made the ultimate sacrifice for our Nation. We owe these fallen heroes a debt of gratitude we can never fully repay. But our Nation will never forget their legacy and that of every mariner who has dared all, risked all, and given all for our Nation.

The Congress, by a joint resolution approved May 20, 1933, has designated May 22 of each year as "National Maritime Day" to commemorate the first transoceanic voyage by a steamship in 1819 by the *S.S. Savannah*. By this resolution, the Congress has authorized and requested the President to issue annually a proclamation calling for its appropriate observance. I also request that all ships sailing under the American flag dress ship on that day.

NOW, THEREFORE, I, JOSEPH R. BIDEN JR., President of the United States of America, do hereby proclaim May 22, 2024, as National Maritime Day. I call upon all Americans to observe this day and to celebrate the United States Merchant Marine and maritime industry with appropriate programs, ceremonies, and activities.

IN WITNESS WHEREOF, I have hereunto set my hand this twenty-first day of May, in the year of our Lord two thousand twenty-four, and of the Independence of the United States of America the two hundred and forty-eighth.

Congressman Garamendi Calls on California Regulators to Require Offshore Wind Developers to Utilize Local Labor, Domestic Vessels, American-Made Components

The following is excerpted from an article released June 12 by the office of Congressman John Garamendi (D-CA).

WASHINGTON, D.C. — U.S. Representative John Garamendi (D-CA-08) sent a letter calling for the California State Lands Commission only to permit offshore wind projects that use local workers, American-built vessels, and domestically manufactured wind turbines. As the Lieutenant Governor of California, Garamendi served as an ex officio State Lands Commissioner from 2007 until 2009 before being elected to the U.S. House of Representatives.

"I strongly support the responsible development of California's burgeoning offshore wind industry to meet our state's electricity needs and tackle the climate crisis by reducing greenhouse gas emissions. Like President Biden, I also believe that building the clean energy economy of tomorrow presents a once-in-a-generation opportunity to revitalize domestic manufacturing and create middle-class, union jobs that can never be outsourced. Skilled American workers are ready, willing, and able to do the job if given the chance," said Garamendi.

"As a former State Lands Commissioner, I call on you to maximize job opportunities for Californians and American workers when permitting offshore wind projects. Being the lead state agency for CEQA is a monumental task, and I am pleased that responsibility has been placed in the State Lands Commission's capable hands. Again, I urge you to apply all three of these criteria when determining whether an offshore wind project is in the best interest of Californians," said Garamendi.

building the clean energy economy of tomorrow with American workers, materials, and know-how. From 2013 to 2018, Garamendi served as the top Democrat on the House Transportation and Infrastructure Subcommittee on Coast Guard and Maritime Transportation, which has jurisdiction over federal maritime laws like the Jones Act, which require that all transportation in U.S. waters be on vessels built and operated by Americans.

In January 2021, Congress enacted the landmark "Garamendi amendment," closing a loophole in the Outer Continental Shelf Lands Act of 1953 by applying all federal labor, environmental, immigration and customs, and antitrust regulations, including the Jones Act, to the offshore renewable energy industry. These same federal requirements have always applied to the offshore oil and gas industries.
